## **Introduction**

The Mid-East Commission on behalf of Ahoskie, North Carolina is soliciting qualifications from engineering firms for planning, engineering and design services for the "Stormwater Action Plan" project. The plan will include mapping of stormwater infrastructure, analysis of the stormwater network, and planning several stormwater improvement projects at the concept level. A public education plan will also be included. For the highest priority project selected by the town, construction level designs will be included, which will be used to apply for available grant funding and to move forward into the permitting and construction phase of the project.

This project was graciously funded through the NC Division of Coastal Management's Resilient Coastal Communities Program, Phase 3 (Engineering/Design). A copy of the grant application is available upon request.

## **Project Description**

This project is for planning, engineering and design of the "Town of Ahoskie Stormwater Action Plan".

Ahoskie has several areas experiencing nuisance flooding from normal heavy rain events. The stormwater system is aging. Pipes are in need of repairs/upgrades, unused impervious surfaces need to be removed, and green stormwater best management practices are needed to provide additional infiltration.

Engineering/Design - Develop a Stormwater Action Plan. This plan will complete a stormwater ground assessment and surface hydrology analysis that will be incorporated into an online mapping system that can submit real-time data to analyze, prioritize, and take action on a problem area. The plan will also incorporate a maintenance plan that will be tracked by the online tool. The plan will include assessing and documenting the type and location of stormwater infrastructure, collecting and analyzing data on the hydraulic flow, assessing stormwater system capacity and functionality, and identifying projects to upgrade the system and improve the ability of the system to convey water and/or improve water quality. Both hard/grey infrastructure and green/nature-based solutions will be considered. A public education campaign on stormwater responsibilities will also be included. Design and Construction drawings will be completed for one priority project chosen in partnership with the community. There will be concept plans for additional projects.

## Selection Process

Statements of Qualifications will be reviewed by a selection committee comprised of Mid-East Commission and/or Ahoskie staff members. Based upon evaluation of the submittal package and consideration of the factors outlined above, the selection committee will select a firm to provide the above detailed planning, engineering and design services. If an agreement cannot be reached with the selected firm, the selection committee will consider another firm.

## **Miscellaneous Provisions**

Ahoskie and the selection committee reserve the right to reject any and all submittals, waive technicalities, and judge the suitability of the proposed services for its intended use, and further specifically reserve the right to make the award in the best interests of the Town and negotiate the total fee amount. Upon delivery, all RFQ submittals shall become the property of the Town of Ahoskie and shall become a matter of public record.

Ahoskie and the selection committee may conduct any reasonable inquiry to determine the responsibility of the respondent. The submission of a Statement of Qualifications constitutes permission by the respondent for the selection committee to verify all information contained therein. If the selection committee deems it necessary, additional information may be requested from any respondent. Failure to comply with such request may disqualify a respondent from consideration.

Please note that Statements of Qualifications may be considered public record. If there are any

sections of your statement that may be considered confidential under law (i.e. trade secrets and proprietary information), please mark these sections of your statement.

#### **Historically Underutilized Businesses**
